PHRF SoCal has received three (3) anonymous rating review requests for:

• SYNDICATE Sail No. 77303 Current Area C Rating /132/132/132/

The Area C Board Representative had set a meeting via Zoom for June 28th at 6PM. All Area C members were invited to attend. In attendance at the June 28th review attempt were Heinz Butner (Area C representative), Dave Booker (member), Tim Hohmann (crew from Syndicate) and Dave Haas (member, owner skipper of Syndicate.) However, there were not a majority of board members in attendance. With no quorum the review was rescheduled to July 19th.

Reason: This boat is unbeatable at its current area C rating of 132/132/132. Its measurements say it

should rate about the same as a Santana 30PC.

Reason: Boat dominates his class. The boat carries a +6 seconds per mile area rating and that should

be removed. Just look at the race results. This boat wins by large margins.

Reason: Understanding that Syndicate is well prepared and well sailed, it should not be winning nearly every race year after year. The competition is just not that bad. The 132 rating in Long Beach is inconsistent with the Kirby 30 rating in other areas

In attendance were Heinz Butner (Area C representative) Jerry Montgomery (Area C board member), Ron Duphily (Area C board member), Jim Breams (Area C board member), and Dave Haas (member, owner skipper of Syndicate.) Note: all members of the Area C board were present.

Comments by David Cattle clarifying that "Regional rating for the boat is 126/126/126, based upon the fact it has +2.5' on I and ISP, and plus 1' on SPL compared to the stock Kirby 30 which rates 135/135/135." Area C Rating 132/132/132.

Contents of the three anonymous rating review requests.

The meeting was conducted in three parts. First was an opportunity for the boat owner to defend the current rating. Second was questioning the owner on the points made in the anonymous rating review. There were no PHRF members present at the meeting challenging Syndicate's rating. The third part was the closed discussion among the members of the board.

Observations:

Syndicate was raced in Area C this year from January until 5/20/21 at which time it was moved to Marina del Ray and is racing there under the same owner.

Syndicates owner defended his rating by describing the the preparation of the boat for racing - sails bottom preparation, etc. The Syndicate crew has raced together for the past five years. The owner made a strong point that he should not be penalized for sailing well - to do so would be a form of "Golf Handicap."

Syndicate is well know in Area C and all observers of her performance agree she is well prepared and well sailed.

The rating review worksheet shows only 9 races during this calendar year in Area C (see note above about relocation to MdR.) It shows that in light wind Syndicate usually wins. The worksheet was repurposed to show how many sec/mi adjustment would be required to change the results. Conclusion: 3-9 second would make no difference in light winds. In stronger wind other boats seem to be more competitive. In all of these races Syndicate is racing against the same 3 other boats. In the opinion of the creator of the worksheet, this is not enough data from which to change a rating.

The Area C board voted unanimously to leave the Area C rating for Syndicate as is at 132/132/132.
