Handicapping:

Cool Man Cool² Sydney 38 Harrell Jones. Requesting base rating change from 27/27/27 to 33/33/33.

Closest comparative boat is Farr40. Boat is well prepared with sails about one year old. 80% of crew has sailed together for 5 years. Raced Transpac 2003 and was 8 in class of 11 and 23 overall.

1st reading of 30/30/30 (M) (S) (P) 7 for 0 against

Alchemy And 77 Alan Andrews made presentation.

Requesting a second certificate with smaller spinnaker, no code "O", jib top or spinnaker. Spinnaker would tack to the bow fitting. 1st reading for -129 / -132 / -132 (M) (S) (P) 7 for 0 against.

Original certificate had some dimension reported incorrectly. (M) (S) (P) 7 for 0 against to correct rating to -138/-141/-141 (P) 7 for 0 against.

Victoria V Scott Diskson made presentation

Weak point is upwind in heavy air. Modifications to boat (gybing centerboard) which resulted in a rating change has not improved performance to level of the rating change. (M) (S) Long Pole -72/-84/-90

short pole -63/-75 /-81

Margaritaville current rating -15/-18/-21 1st reading of -63/-69/-75. Requesting owner to submit a new application (M) (S) (P) 6 for 0 against 1 abstention.
