Appendix C Preamble (M) (S) (P) to accept the preamble on 1st reading basis. Appendix C matrix was presented by Cole Price. Everyone thought it was an excellent start. current rating -60/-66/-72 (long pole configuration)

Requesting dual certificates for a short pole 21.5 and smaller spinnaker and for a long pole 25.0 with larger spinnakers.

(M) (S) for rating of -54/-57 -63 with short pole and small spinnakers (P)

Mad Dog Schock 40 Ed Feo. Matt Brown owner rep. CURRENT RATING 6/-18/-21 Presented proposed changes to foils. Larger foils for upwind speed and easier handling in heavy air and confused seas. Proposed changes would add 15% to fore and aft foils. No change to keel. (M) (S) (P) for adjustment of -3/0/0 which would make rating 3/-18/-21.

Adjustment contingent on approval of Chief handicapper.

Baseline NPT 41 Ray Tostado owner. Added 3" lead area forward of the rudder post centerline, and about 6" of draft. There is no alteration of the rudder cord profile, aft plane section or aft trailing edge. There will be no addition to the upper wetted edge. (M) (S) (P) motion for no rating adjustment.

Downwind 58 tabled to April meeting. Requesting pictures of the underbody, keel, rudder and interior. Comparable boats are the Tayana 55 and Swan 58.

Mark Callahan and designer Tom Vernan requesting rating for this new boat.

Rig dimension is close to Magnitude 80. Higher potential for reaching. Down wind would be slower. Swept back spreaders.

Creeper Santana 30GPM

Drew Freides asked that Jerry Kaye present a letter written by Art Engel regarding the modifications made to Creeper. Owner allegedly did not report removal of lead ballast and when it was discovered that the lead had been removed Area B did not make a rating adjustment. Area B has given Creeper +6 area adjustment for performance.
