Richard Mainland Paddy Wagon Ross 40 Current rating 39/30/27 requesting rating change to buoy to 48.1982 design built in New Zealand, purchased in 2002. Wide bottom which can be sticky upwind, can drive relatively deep downwind with asym spinnaker. Main Sail is a 2003, aysm is 2003 or newer. Dips. 12800. (M) (S) for 3 seconds on buoy rating. Requesting Richard to recalculate race results with a 3, 6 and 9 second adjustment. Boat had raced in the Northwest and results from the NW would be helpful.

Tom Schock . Requesting a suggested rating for adding 4.4 feet to mast height. Total main sail area will remain the same with removal of o/s roach. Spar would be 50 lbs heavier, jib size and shape would be unchanged. 175 sq ft more of spinnaker 10% increase. (M) for 3 -6 seconds Buoy, 6-9 seconds RLC and 9-12 OWC adjustment.
