Boat has been rebuilt with no modifications below the waterline, no change to rig. 12 bulkheads have been added to make boat stiffer, rear bunks have been moved to center of boat, toe rail has been removed, transom cut away and reinforce to accommodate the outboard and bracket. Lead to added to bring boat up to original weight.
