The following are Meeting Minutes from the **Area C** meeting that was held on 3/12/2013:

Review of Schock 35 Area C Adjustment

The Board had considerable discussion regarding the +3 Area Adjustment which applies to the Schock 35 fleet, and on the basis of those discussion, and an evaluation of the race history and observed performance of the Schock 35 in Area C, the Board conducted a First Reading regarding such +3 Area Adjustment. At the First reading the Board voted to remove the Schock 35 Area C Adjustment of +3/+3/+3. If the Board's decision is confirmed at the Second Reading, the Schock 35 Area C rating will change from 75/75/75/ to 72/72/72. The Board encouraged the input of Schock 35 owners at the Second Reading, and requested that the fleet secretary to notify the Shock 35 Fleet of the results of the First Reading, and the time and place of the Second Reading, which will occur at the PHRF Area C Board Meeting at 7:00 pm, April 8 at the Long Beach Yacht club.

Old Business:

- a) Race Group Classification System. The Board has previously decided to develop a Race Group Classification System to be considered by the PHRF Regional Board as a tool to be recommended to yacht clubs as a more equitable way of establishing PHRF race classes than just using numerical rating bands. The Board has initially decided that this classification system will recommend that race groups be defined by first establishing certain boat categories, for example, boat lengths, hull types-displacement vs. non displacement, and rig types-sprit vs. non sprit, and then, within such categories, using PHRF ratings for handicap purposes. Rick Gorman and Alex Cross prepared a preliminary report and recommendation which provided the Board with initial data concerning boat categories. The Board Members at the meeting, made changes and comments to the preliminary recommendation, and those comments will be incorporated into a further developed boat category plan to be presented at the next meeting. The goal will be to send to the Regional Board a recommended Race Group Category Plan, which if adopted by the Regional Board, would then be sent to the yacht clubs as the PHRF recommended approach to race group creation.
- b) <u>Periodic Boat Review Program</u>, The Board has agreed to periodically review results from selected regattas and races and, on the board's own initiative, to take action to review and adjust ratings (up or down) based "the results and observations of actual performance during races". The Board is focused on the following regattas/series, with the board member primarily responsible for such review designated in parenthesis and any potential ratings issues noted:
 - -SBYC Sunday Sailor Series (Katinszky)
 - -SBYC Saturday Sailor Series (McClure)
 - -LBYC Catalina Island Series (Price)
 - -SBYC Pop Tops (Thurs Night) (McClure/Cross)
 - -LBYC Wet Wed (McClure/Cross)
 - Long Beach Race Week (TBA)
 - -SCYA Midwinters (McClure/Price)
 - -PHRF Championships (TBA)
 - -Selected offshore events (Gorman)

The Schock 35 review and rating change (First Reading) came from this review and no other boats or fleets were recommended to be reviewed at this time.
