Chief Handicapper's Report:

1. BEN10R's 2nd Reading : 75/75/69/ (were 75/69/63/): Boat doesn't sheet well due to shroud position/sheeting angle. Board voted 2nd reading: 75/75/69/

- 2. <u>COCKTAIL & Tesoro:</u> Harbor 30 #7630. Michael Rettie Rating Review 1st Reading:
 - Harbor 30 currently rates 120/111/105
 - Owner of Cocktail presented race history spreadsheet for both Harbor 30's racing in SoCal
 - **First Reading**: Board voted on a rating **135/117/108** (adjustment of +15/+6/+3) for configuration using Hoyt Boom only (provisional)
- 3. PHRF Big Boat Review Continuation per PHRF SO CAL Regional Board, the Fleet

MARGARITTAVILLE 1 ¹/2:

Tabled. Need spreadsheet information or boat may be reviewed later in year after 2013 race results are reviewed and assessed, considering Big Boat Review changes made to competitors.

4. <u>SLEEPER, JNNU44, 56284, Ron Simonson</u>, 2nd Reading. Current rating is 81/78/78. 1st reading was 72/66/66/ original vote 3/19/2013 RBM.

- Boat owner says that the JNNU44 that is a Sun Odyssey Regatta model
 - Regatta has a taller rig
 - Slightly deeper keel
 - No Port Lights in the hull
 - Max turning on rudder is 45 degrees, which hurts its ability to turn tight
 - Owner says that boat doesn't point as well as Schock 35's and J109's
 - Brian Dare sailed on Sleeper on 5 of the boat's 1st place races
 - Nor Cal's ratings are RLC: **75** & OWC: **66**
 - IRC TCC of 1.045 equates to a PHRF rating of 65
 - IRC certificate contained some inconsistencies in the configuration that it rated from boat being presented (IRC showed iron keel, roller furling genoa, etc.)
 - Two of Sleeper's competitors addressed the board and presented that Sleeper sailed through the lee of a J35 as it passed them under them. They also sailed higher and faster then a Schock 35. The owners stated that neither the Frers 39 Gator, the J35 or Schock 35 were as fast on a jib or spinnaker reach or downwind under spinnaker as Sleeper.

- 2nd Reading: Board voted to adjust by -3/-9/-9, from 81/78/78 to **78/69/69**

5. <u>TANTRICA</u>, MULL22, 8422, David Paudler, Rating Review First Reading voted: from 150/153/147

6. <u>FAST REORGG</u>, HUN50, 56054, Ron Orr, Owner 1st reading of Rating review:

- Boat hit whale and had work done to repair it
- Boat is rated with water ballast
- Boat moves fast in a breeze kept up with Farr 40's in 15 to 18 Kts
- Current rating is 33/21/18
- **First Reading:** Board Voted to adjust 0/+9/+6 to **33/30/24**

7. <u>CHISPA</u>, J-97, GBR 5997r, Thomas Cullen, Initial Rating: Rated boat: 102/96/90
