- Meeting convened at 6:00 pm
- Approved December Meeting Minutes that included latest changes
- Discussed possibility of rating multihulls in under PHRF SoCal
 - PHRF San Diego is now rating multihulls
 - Talked about potentially using PHRF Lake Michigan Class Rules and ratings having a separate Handicapper
- Area Reports
 - Area C did a First Reading on Cal 40's, and voted to adjust them -9 sec/mi
 - Area G rated some multi-hulls
- Cal Yacht Club PRO addressed the board to discuss a situation where a OD boat was moved into a PHRF class and allowed to race without a valid PHRF certificate because there were not enough boats to form an OD fleet..

1. **RADICAL DEPARTURE**, BEN25P, USA 350, Dennis & Mark Rosene:
Owner Requested Rating Review. **Board voted to make no change. Suggested that the Area board address issues related to local conditions.**
2. **DANGER ZONE**, TAY32, 4128, Stephen Keneally: Owner Requested Rating Review: **First Reading: Adjust from -6/-12/-21 to 33/21/15 (Remarks on certificate need to note "O/S main & Adj Cap Stays")**.
3. **ENCORE**, IRWCIT41, 7288, Bart Mc Entire: Owner Requested Rating Review: **First Reading: Adjust from 51/51/51 to 78/78/78.**
4. **HOT TICKET**, Schumacher32, 51001, Jeff Burch:
Owner Requested Rating Review because of the J ratings:
First Reading: Adjust from 48/33/33 to 51/45/45.
5. **HEARTBEATII**, BEN44.7, 52656T, Chuck Brewer, Rated for Modifications:
Boat currently rates 30/27/24 with SPL:18.0 & ISP: 63.2. Owner requested rating of 39/39/39, which applies to SPL:15.8 & ISP: 57.4. Boat owner needs to reduce SPL and ISP to SPL:15.8 & ISP: 57.4 if he wants rating of 39/39/39. Otherwise, current rating of 30/27/24 is correct for current dimensions. Tabled because Boat Owner was not present for meeting.
6. **FAST REORG**, HUN50, 56054, Ron Orr: Owner Requested Rating Review
Rated Modifications: Adjust from 33/30/24 to 51/42/39.

7. **TP52's & MARGARITAVILLE 1/2**, Rating Review: Competitors provided PHRF board race history and related information. **The data provided is from the 50' Class Fleet (NOT the TP52 Fleet)The Board decided to table the review so that it representatives of Margaritaville could respond to data provided by the TP 52 fleet and provide data of their own at the February meeting.**
