Requestor's Reason:

- 1. DISTRAXION rated incorrect as a standard XP44 but should be rated as the optimized XP44 TM DK (carbon tall mast, deep keel). Other regions rate the TM DK at 12 & 6 (W/L & DIS) or 0 & -6.
- 2. Has researched the XP44 ratings and there are basically a cruising and racing version and believes that DISTRAXION was rated with the cruising version, not the optimized XP44 TMDK."

  - o Area B Representative offered to contact owner
- 4/19/19 OWNER OPPOSED THE 1ST READING
- 5/21/19 Owner explained:
  - o How he came up with his data that he submitted from numerous races
  - o Only XP44 on west coast for years
  - o Explained differences between the options to the type of boat
- 5/21/19 Gary Ezor's comments from an email was read into the Minutes by the President:
  - o "...Just because you decide to add a double refrigerator and a water maker to your racer cruiser doesn't mean you get a lower rating! So if

- that's the case I get to finish the interior off of Coquille and add a tv and other amenities and then the other Farr40s should have to give me time! Nonsense!
- "Ratings should not be significantly different for XP44 TMDK boats east or west coast as we all have various weather and wind conditions.
- "Regarding displacement, the listed displacements of various boats in Long Island range from 21,395 to 20,125 as compared to 21,277 for Distraxion.
  - "That is up to the owners discretion on how many stoves, watermaker or extra gear that they wish to race with or without.
- "The boat is now rated just like the other "optimized" or racing version XP44 TMDK boats!
- "As for the modified XP44 Sitella, which has had various amenities removed to reduce weight and extras added to improve speed the random leg rating was reduced to -06 from 12 or 18 seconds per mile adjustment.
  - "The adjusted rating for Distraxion is not being compared to Sitella.
- o "The fact that there is not as much high level of competition sailing against Distraxion out of King Harbor, per Jeff's comment, attests to the fact that the overwhelming opinion amongst their completion is that Distraxion is unbeatable with a "fat" handicap of 33 seconds per mile in all but very light wind conditions (under 5 knots).
- "How he has arrived at all his unverifiable statistics of the race competitors is impressive but notwithstanding inconsistent with his results which prove his rating is incorrect.
  - "There are many other racers who do just as much preparation and have competent crew and also have great boats that are rated fairly.
  - "I believe the PHRF board has now corrected the rating in the case of Distraxion..."
