## Website Usage

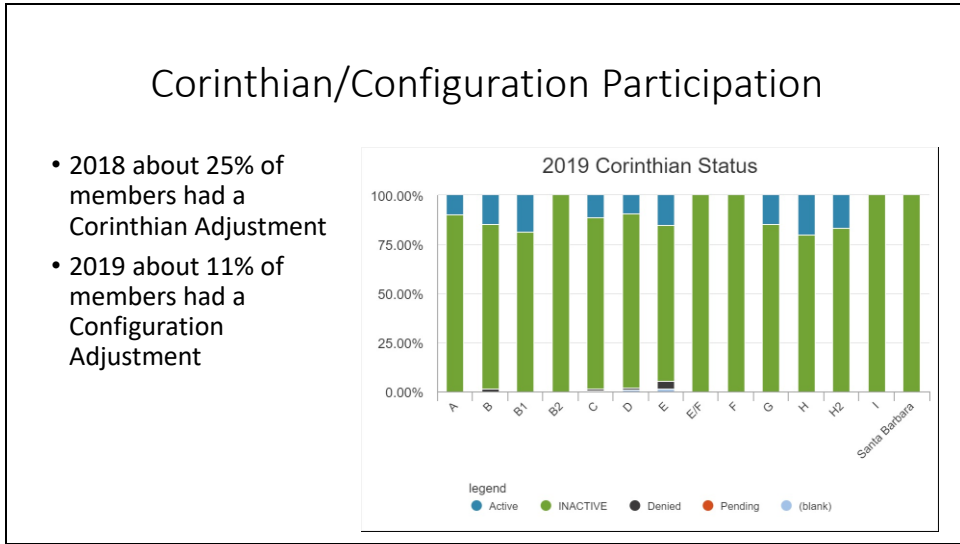
- Weekly Page Views range from 500 to 3000

Bring Rig and Sail Parameters in Sync with National Standards (USS)

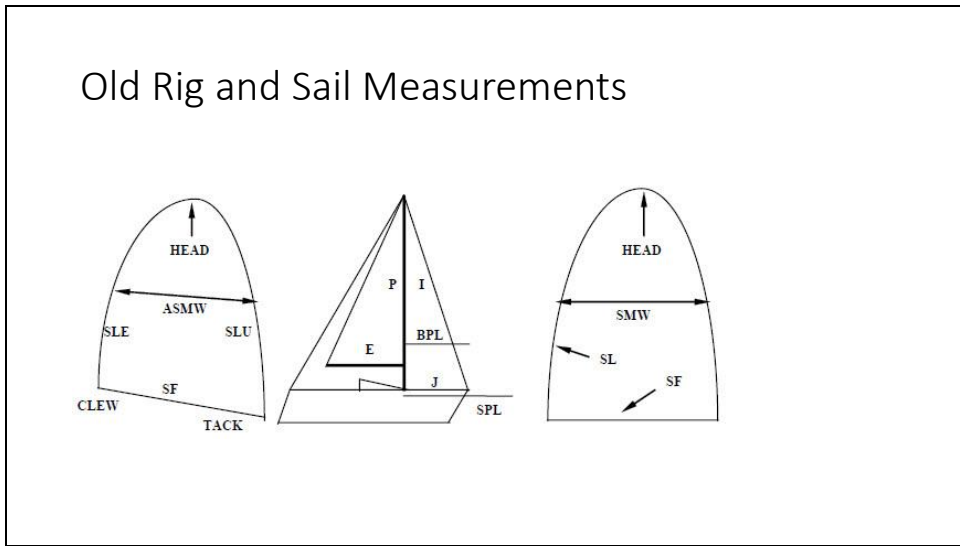
- New Rig and Sail Definitions and Diagrams

**We Are Requiring Members to Enter Their Spinnaker Measurements on the 2020 Renewal Form**

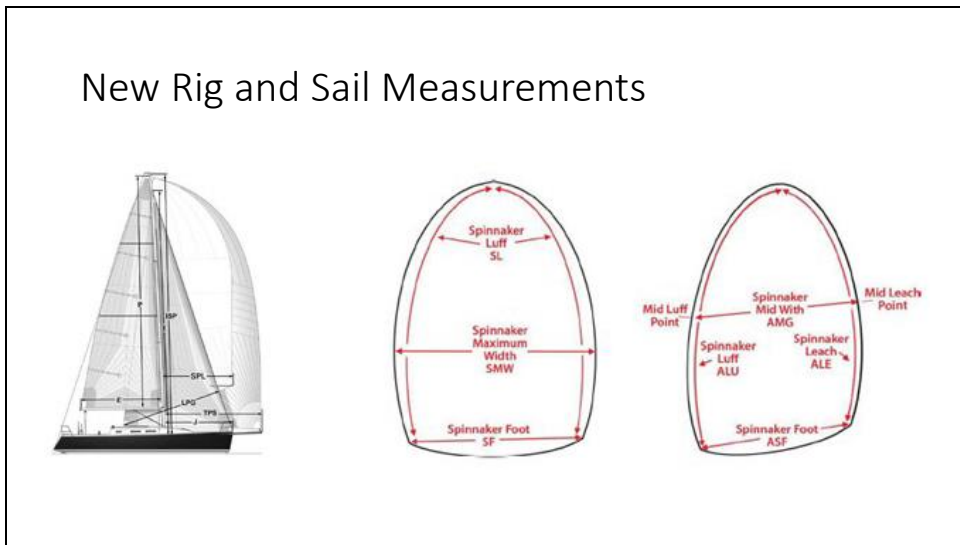

	Old Formula	New Formula
Symmetrical Spinnaker Area	$(J \times 1.8) \times (I \times 1.8)$	$SL \times (0.5 \times SF + 2 \times SMW) / 3$
Asymmetrical Spinnaker Area	$(SLU + SLE) \times (ASMW/3 + SF/12)$	$(0.5 \times ALU + 0.5 \times ALE) \times ((0.5 \times ASF + 2 \times AMG) / 3)$
Performance Factor	$((0.67 \times LWL) + (0.34 \times LOA)) \times (SA/D)$ where $SA = ((SPL \times ISP) + (P \times E)) / 2$	$((0.67 \times LWL) + (0.34 \times LOA)) \times (SA/D)$ where $SA = ((MSP \times ISP) + (P \times E)) / 2$ and $MSP = \text{MAX}(J, SPL, TPS)$
