• Recap of Changes to Rules: (Judge Advocate)

- o Revision 07/09/21
 - Rule 2.6(d) was removed. This rule previously stated that PHRF SoCal does not rate foiling boats.
 - Rule has been removed therefore PHRF SoCal can rate foiling boats

Motion by Regional Board to Amend Bylaws

- Approved by Regional Board to bring before PHRF SoCal Membership for its approval:
- Change to Bylaw
 - A new elected officer is VICE HANDICAPPER
 - The Vice Handicapper will work with the Chief Handicapper to manage the process of rating boats.
 - o Rating boats is the primary function of PHRF SoCal,
 - o It was felt that PHRF SoCal could use additional resources to help the process and help the Chief Handicapper.

- With approval of the Judge Advocate and the Regional Board a motion to amend the Bylaws to reflect this additional elected position was passed
- MOTION PRESENTED TO THE GENERAL MEMBERSHIP TO ADD THE POSITION OF VICE HANDICAPPER TO THE EXECUTIVE BOARD (amends ARTICLE IV ELECTED OFFICERS and FUNCTIONS)
 - Discussion as to the value of adding one more position to the Executive Board
 - Add one more Executive Board Member vs Increasing number years of the Regional Board Members
 - Other options would be to increase the term period from four (4) years to 6 years
 - Area Board Members and Representatives are difficult positions to fill
 - A point was made to have a successor in place to be a Chief Handicapper
 - Not necessary for a voting position
 - Advisors do not have a vote
 - o How would authorizations be issued
 - How is authority to be divided
 - Approved Bob H, Bob L, Dan, Paul, Sue
 - Opposed Lisa
 - Abstention: John
 - Approved with 5 "Approved," 1 "Opposed," and 1 "Abstention"
